‘Digitalisation and access to justice: challenges and opportunities’

Overview: Digitalisation and innovative technologies are making their impact on the legal services and the legal profession. Benefits include lower legal costs and greater access for EU citizens and new business opportunities for the legal profession. On the other hand, new technologies present challenges for the lawyer/client relationship including client privilege and the security of data, as well as for the legal profession generally posed by new legal tech players – how to ensure a level playing field? The European Commission is working on a new initiative on the digitalisation of company law and is broadening its focus on the impact of technology. Meanwhile, the European Parliament is calling for EU rules for the fast-evolving field of robotics, to settle issues such as compliance with ethical standards and liability for accidents involving driverless cars.

‘Rethinking EU citizenship in the wake of BREXIT’

Overview: Brexit raises access to justice issues for UK and EU citizens and poses challenges for lawyers and their clients. What is EU citizenship? What are the rights guaranteed by EU citizenship, including the notion of acquired rights? How can the rights of EU and UK citizens, including free movement, be protected? ‘UNGPs on business and human rights for EU lawyers, citizens and business’

Overview: the UN Guiding Principles on business and human rights are guidelines, based on international conventions on human rights, on how States and business should prevent, address and remedy human rights abuses. In June 2016, 5 years after the adoption of the UNGPs, the EU Council adopted conclusions



on the UNGPs supporting their implementation and drawing particular attention to the need for EU member states to provide ‘effective remedies for victims of business-related human rights abuses’. The Council called on the European Commission to address in the issue in a future Action Plan on Responsible Business Conduct. The UNGPs pose specific challenges for lawyers who represent both the victims and perpetrators of abuses, and for lawyer/client privilege. How should lawyers advise clients in complying with the UNGPs? How should lawyers apply the UNGPs within their own business? How can the EU, as a global standard setter, assist in implementing the UNGPs, and provide guidance to the legal profession? Should the EU interventions be binding or not?
