**'Impact of technology on the future of EU justice'**

*Overview: : the rise in the use of technology has had a huge impact on the legal sector, leading to outsourcing, the unbundling of legal services, growth in on-line provision (including through mobile phone apps), automated solutions and comparison websites. On the one hand, this has facilitated access to justice for those who might not previously have considered such a solution. On the other, it raises significant questions over the future regulation of the legal sector eg the status of new online legal platforms (highlighted in the 2015 European Commission consultation on on-line platforms and the collaborative economy). How should governments, the legal professions and citizens react to the changes?*

***'Migration and the Rule of Law'***

*Overview: the huge flows of migrants that have prompted such a crisis within the EU have also caused a crisis for the rule of law, which is being tested in two opposing directions: first, the current law is ignored by migrants and Member States alike as if 'playing by the rules' has no meaning; and second, the EU's values of solidarity, humanity and respect for human rights are ignored as borders close and migrants endure harsh and sometimes life-threatening conditions. What is the outlook for the rule of law if the crisis persists for years?*

***'The rising role of International Courts in law making'***

*Overview: There has been significant growth recently in the number of international courts. Although most of the activity has been in the international criminal field, the European Commission has recently proposed an international trade court to deal with investor-state disputes. Increasingly the European Courts are setting new standards e.g. on data privacy - overruling 'Safe Harbour agreement; future ruling on how to categorize 'Uber' and similar online platforms. Europe has, in addition, a long post-war experience of the Court of Justice of the European Union and the European Court of Human Rights. Do international courts, dealing with a variety of jurisdictions and their national particularities, bring a new perspective to decision-making? Since Europe has taken the lead with its own courts, does it have specific experience to bring to future developments?*
